Privacy Policy

This Privacy Policy applies to https://cloudstore.co and Cloudstore ("Company") and governs data collection and usage. For the purpose of this Privacy Policy, unless otherwise noted, all references to the Company include https://cloudstore.co/. The Company's website is a marketplace site. By using the Company website, you consent to the data practices described in this statement.

Information We Collect

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -First and last name
- -Mailing address
- -Email address
- -Phone Number

- -Tax ID number

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Tracking User Behavior

Automatically Collected Information

- -Debug to identify and repair errors that impair existing intended functionality;
- -Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech
- -Comply with the California Electronic Communications Privacy Act;
- -Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics
- -Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- -Comply with a existing legal obligation; or
- -Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information

Children Under Thirteen

The Company does not knowingly collect personally identifiable information from children under the age of 13. If you are under the age of 13, you must ask your parent or guardian for permission to use this website.
